Project Description:

The Master Plan for Irving & John Anderson County Park identifies Mid-Term development goals for the park as outlined below. This proposal supports the "Take Care of What We Have" pillar identified within the 25 Year Park & Trails Legacy Plan. Proposed projects to be implemented in 2017 -2019 within this funding request includes the following: 1. - Installation of a one acre now mow recreational field for informal family use located west of the existing parking area and picnic shelter. 2. - Implement a system for canoe storage and rental near the access to Horseleg Lake to encourage non-motorized usage. 3. - Construct two ADA accessible wildlife observation platforms situated to overlook Horseshoe Lake and the wetland area west of County Road 18. 4. - Expand parking spaces by 10 - 15 vehicles near the main picnic shelter and construct 2 additional gravel parking areas within the park. One 5 space parking area for horsetrailer west of County Road 18 and one 5 space trail head parking area on the NE corner of the park. 5. - Provide electricity with breaker, 20 amp plug ins, and motion detection light to existing picnic shelter. 6. - Drill well and install drinking fountain near existing picnic shelter. 7. - Construct a permanent restroom facility near existing picnic shelter. 8. - Create visual artistic sculpture of Sandhill Cranes near park entrance. 9. - Install 2 interpretive panels to help educate the public about the importance of the Anoka Sandplain and 10 trail delineation signs to aid in trail navigation. 10. - Install rock climbing structure, slide, swing set, crawl through stump, eagle's nest, and beaver lodge in children's natural play area. 11. - Resurface 3 miles of multi-use trail to allow for ADA accessibility.

Project Cost Breakdown: 1. - Installation of a one acre now mow recreational field for informal family use located west of the existing parking area and picnic shelter (\$6,000). 2. - Implement a

system for canoe storage or rental near the access to Horseleg Lake (\$8,000) 3. - Construct two wildlife observation platforms situated to overlook Horseshoe Lake and the wetland area west of County Road 18 (\$10,000) 4. - Additional parking spaces for 10 - 15 vehicles near the main picnic shelter and 2 additional parking areas within the park (\$20,000) 5. - Provide electricity with motion detection light to picnic shelter (\$10,000) 6. - Drill well and install drinking fountain near existing picnic shelter (\$12,000) 7. - Construct a permanent restroom facility near existing picnic shelter (\$40,000) 8. - Artistic Sculpture of Sandhill Cranes near park entrance (\$9,000) 9. - 2 interpretive panels and 10 trail delineation signs (\$5,000) 10. - Install rock climbing structure, slide, swing set, crawl through stump, eagle's nest, and beaver lodge in children's natural play area (\$50,000) 11. - Resurface 3 miles of multi-use trail to allow for ADA accessibility (\$50,000) Estimated costs total \$220,000 to come from Park Legacy Funds and Isanti County Parks (ICP).
